

BACKGROUND

EU's next, 6th Framework Programme will be launched in November 2002 and will last for five years. The new work programme has seven priority areas, within which there are niches also for forest research. The new instruments introduced by the 6th Framework Programme – Networks of Excellence and Integrated Projects – aim at creating a European Research Area (ERA). This sets new challenges also for forest research.

In order to promote the dialogue and exchange of information between the EU and forest research community, EFI, within the EU-funded IMACFORD project (QLK5-CT-2002-3022), will arrange a one-day seminar focusing on the role of forest research in the 6th Framework Programme.

The keynote speakers of the seminar include representatives of the European Commission. The role of forest and forest-related research in the 6th Framework Programme and ERA will be discussed at a panel session in order to identify potential topics for networking and to discuss the links to relevant other disciplines. Participants of the forest research community will have an opportunity to present their views and visions on how forest-related research can contribute to the 6th Framework Programme. The seminar can serve as a platform for making contacts with other actors in the field.

AIMS

- to encourage dialogue between the EU and forest research community on the role of forest research in the 6th Framework Programme and ERA, and to offer a platform for discussion and exchange of information
- to chart forest related research needs in the light of the 6th Framework Programme and ERA
- to chart existing research capacities and networks in Europe in the field of forest and forest related research, to meet the needs of 6th Framework programme and ERA
- to explore links to other relevant disciplines (e.g. climatology, environmental sciences, information technology etc)

- Forest researchers
- Representatives of relevant other fields of research
- Representatives of end users of forest research and other stakeholders (industry, forest owners, policy-makers)

KEYNOTE SPEAKERS

The keynote speakers and panelists include representatives of the European Commission, representatives of end-users of forest research (forest industry, forest owners etc), forest researchers of key research topics as well as researchers representing other fields of science relevant to forest research.

Participants willing to present a poster on a research topic, network or project concept/plan relevant for the 6th Framework Programme are welcome to do so. The size of the poster is a standard A3. The deadline for submitting the title of the poster is 31 October. Those wishing an abstract to be delivered for the participants during the event are asked to submit a one-page abstract by 31 October to Ms. Brita Pajari at EFI (brita.pajari@efi.fi).
